1. **PRESIDENT** : He presides over all the meeting of both the General Body and executive Committee. He can have a casting vote in the position. He can supervise all the branches of the Club.
2. **VICE-PRESIDENT**: He is to assist the President in discharging his functions in the absence of the President. He will perform the duties of the President as entrusted by him.
3. **SECRETARY**: He is the Chief Executive Officer of the society and \custodian to all records relating to the Club and Correspondent on behalf of the club. He has to take on record of all Minutes of the Club and to convince both the bodies of the Club and with the permission of the President he has to guide the Treasurer in preparing the budget and expenditure statements to be put before the General Body for its approval.
4. **JOINT SECRETARY** : He has to do the work as entrusted by the Executive Committee. He has to assist the Secretary in discharging his duties. In the absence of Secretary he can perform the duties of the Secretary.
5. **TREASURER** : He is responsible person for all the financial transactions relating to the Club. He has to maintain accounts properly along with purchases. He has to prepare budget and expenditure statement of the Club with guidance of the Secretary. He has to operate the amounts of the club jointly with secretary and President.
6. **OFFICE-BEARERS**: They are responsible persons towards doing the activities of the Club which the Executive Committee entrusted to them.
7. **QUORUM**: Half of the total Members of the General body meetings and 1/4th of the Executive Body meeting. No Quorum is necessary for the attainment of the Aims and objects.
8. **FUNDS**: The Funds shall be spent only to the attainment of the objects of the Society, and no portion hereof shall be paid or transferred directly or indirectly to any of its members through any means.
9. **AMENDMENTS**: No amendments or alterations shall be made in purpose of Association unless it is voted by 2/3 of the members present at General Body Meeting concerned for the purpose and confirmed by 2/3 of the members present at a Second Special Meeting.
10. **WINDING OF** : In case, if the society has to be windup the property and the funds of the society remains after full satisfaction of the liabilities of the societies shall be transferred of or paid to some other institutions with similar aims and objects.
